2010 Special Education Administrator of the Year Award

The MASE Board of Directors established this award for members in the spring of 1991, and the first awards were presented at the 1992 Spring Conference. The purpose of the award is to honor one or more administrators from throughout Minnesota for excellence in special education leadership.

Selection Criteria

1. Nominees must be a practicing administrator and a member of MASE.
2. Nominees must have a minimum of 5 years administrative experience.
3. Nominees must have demonstrated a concern for students/families with disabilities.
4. Nominees should be able to demonstrate active involvement in professional and community affairs.

Selection Procedure

1. Nominees may be self-nominated or nominated by another member of MASE.
2. Nominations must be made by January 29, 2010.
3. Nominations must be made on the official MASE form available through the MASE office. (Attached.)
4. The Nominating Committee will serve as the selection committee and determine the selection process. The recipient will be selected and the MASE office notified by February 15, 2010.

The Award

1. The award will be made at the MASE/MASA Spring Conference.
2. The recipient will be presented with an individual plaque.
3. A news release will be distributed to pertinent media in the coverage area of the recipient(s).
